RE: Authority to amond a resolution approved on April 12, 2018 to correct the name

of the consultant from Larry Weaner Landscape Associates to Larry Weaner

Landscape Design Associates, Inc.

By resolution approved on April 12, 2018 (the "April 12th Resolution"), your Honorable Board authorized the County, acting by and through the Department of Planning (the "Department"), to enter into an agreement with Larry Weaner Landscape Associates to provide landscape design services in connection with the restoration of approximately 125 acres of degraded grasslands on top of the former Croton Landfill at Croton Point Park in the Town of Cortlandt for a not-to-except amount of \$47,450 and a term beginning on April 16, 2018 and ending April 15, 2019.

Following passage of the April 12th Resolution, the Department learned that the correct corporate name of the consultant is Larry Weaner Landscape Design Associates, Inc. Accordingly, authority is now respectfully requested to amend the April 12th Resolution in order to correct the name of the consultant from Larry Weaner Landscape Associates to Larry Weaner Landscape Design Associates, Inc.

Except as specifically amended hereby, all other terms and conditions set forth in the April 12th Resolution shall remain the same.

Accordingly, approval of the attached resolution is most respectfully requested.
