The 2018 Non-Recurring Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for the milling and resurfacing of winter-damaged segments on four County roadways: Mamaroneck Avenue, Midland Avenue (Rye), Theodore Fremd Avenue, and the Bronx River Parkway. Work also includes the Kensico traffic circle and improvements and replacement of curb cuts, new pavement markings and traffic signal loops.

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that these various roadways meet current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further
