Authority is respectfully requested from your Honorable Board for the County of Westchester (the "County") to enter into an agreement with the United States Department of Housing and Urban Development ("HUD"), for a term from August 1, 2018 through July 31, 2019, in order to accept a grant in the amount of \$260,000.00, which will fund work and services related to the County's Homeless Management Information System (the "Grant Agreement"; HUD Grant Number NY0749L2T041708).

The goal and objective of the proposed agreement is in the best interests of the County in terms of fiscal responsibility, as the proposed agreement will make available to the County the funds necessary for the County to pay for work and services related to the County's HMIS. The goal and objective of the proposed agreement is also in the best interests of the County in terms of public health and safety, as the County's HMIS is designed to track and monitor the placement and status of the homeless clients of the Department and thereby better serve them.

The goal and objective of the proposed agreement will be tracked and monitored by the Department, in accordance with the requirements of HUD.

The proposed agreement does not constitute procurement. Accordingly, the provisions of the Westchester County Procurement Policy do not apply to the proposed agreement.
