2.) Extend the term of the agreement by five (5) years, to a new termination date of March 13, 2024, for a total amount not-to-exceed \$142,500.00 during said period for maintenance services for RiskMaster.

In 1998, the County entered into an agreement with Dorn Technology Group, Inc. ("Dorn Technology") for the licensing, installation and support of a "RiskMaster" risk management software system. Included in the agreement was the provision of software maintenance services for one year, to commence upon completion of the warranty period. This initial software maintenance period ended in 2000. Since that time, the County has periodically renewed the agreement in order to receive continued software maintenance.

Notably, during the course of the maintenance agreement, Dorn Technology changed its name to Mynd Corporation. Subsequently, Computer Sciences Corporation ("CSC") acquired Mynd Corporation and all of its assets.

The most recent extension of the agreement in order to receive continued maintenance services was authorized by your Honorable Board by a resolution approved on March 12, 2014. That resolution authorized the County to amend the maintenance agreement in order to extend

the term for an additional five (5) years, to a new termination date of March 13, 2019, for a total cost of \$161,078.99 during that new, five-year period. The amendment was subsequently executed.

At this time, it is necessary for the County to receive upgrades to the three (3) component products contained within the RiskMaster software: RiskMaster, Business Intelligence and MCM/document management application. These upgrades are vital if the County is to utilize new functionalities and realize enhanced security features for RiskMaster. The cost to obtain said upgrades, based on CSC's cost schedules and anticipated work, has been calculated as \$19,840.00.

The savings associated with the above-mentioned upgrades was partially achieved based upon the County simultaneously agreeing to extend its maintenance agreement with CSC for RiskMaster by five (5) years, to a new termination date of March 13, 2024, for a total amount not-to-exceed \$142,500.00 during said period for maintenance services for RiskMaster. The cost for said maintenance services was successfully negotiated by the County's Department of Information Technology, such that the annual costs during the five-year term will be kept flat, at \$28,500.00 per year, rather than starting at a higher amount and/or increasing year over year. This resulted in a savings to the County of approximately \$48,000.00 over the five-year period.

The above-described savings that resulted from negotiations are particularly notable because RiskMaster software is proprietary to CSC (i.e., it holds all the intellectual property rights to this software and has not licensed any third parties to maintain or upgrade its software). This means that only CSC can provide upgrades and maintenance to the existing RiskMaster system. The only alternative to the proposed agreement for software maintenance and upgrades to the RiskMaster system would be to procure an entirely new system at great cost and which would also require retraining Risk Management personnel to use a new system, which is unnecessary. Based on the fact that only CSC can provide these necessary upgrades, we recommend that this procurement be classified as a sole source procurement pursuant to Section 9 of the Westchester County Procurement Policy.

The proposed amendments will serve a public purpose by ultimately providing the Office of Risk Management with upgraded and well-maintained software, with greater functionality and security, for its risk-management purposes.

RESOLVED, that the County is also hereby authorized to amend the Agreement by extending the term thereof by an additional five (5) years, to a new termination date of March 13, 2024, for a total amount not-to-exceed \$142,500.00 during said period for the Services, payable to CSC in the following annual amounts:
