This contract is for a scheduled duration of three years.

The goals and objectives of the Contract are to obtain the services of a contractor who has the equipment, manpower and resources available to undertake the struvite removal & prevention services at the Yonkers Joint Water Resource Recovery Facility located on 1 Fernbrook St, Yonkers, New York 10705

DEF personnel will inspect and supervise the work performed by the selected Contractor. Verification by DEF is for payment and tracking purposes only and in no way relieves contractual responsibility from the Contractor for completing the work as described herein. The Contractor will be responsible to comply with all applicable regulations and industry & trade standards.

This Contract is deemed to fulfill a public purpose as the services provided under this Contract protect the building facilities and equipment systems, centrate lines that are operated by DEF personnel and enable the Department to carry out its basic mission to provide wastewater treatment and maintaining satisfactory water quality.

The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further;
