The 2019 Capital Budget contains funds for the above referenced project.

On December 13, 2018, your Honorable Board approved a resolution rejecting all bids for Contract No. 17-522, Site Improvements and Building Restoration, Miller House, Town of North Castle, New York. The basis for the rejection of bids for Contract No. 17-522 was due to the fact that all of the bids received exceeded the budgeted amount for the project.

Subsequently, the County has requested a Capital Budget Amendment for additional funds for this project and therefore, is requesting authority to re-advertise this project as Contract No. 17-522-Rev., Site Improvements and Building Restoration, Miller House, Town of North Castle, New York.

The work under this contract consists of providing all necessary labor, material and equipment required to perform work for site improvements and building restoration of the Miller House.

In accordance with Chapter 635 of the Laws of Westchester County, the Department of Public Works and Transportation has evaluated the needs of this project and determined that a Project Labor Agreement (PLA) will benefit and enhance the interests of the County in the timely and efficient completion of the project. The Contractor to whom this contract is awarded will be required to execute a PLA.

The objective of this contract is to restore the historic Washington's Headquarters Museum.

This contract is in the public's best interest because it will extend the life of the Miller House building.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

RESOLUTION

Upon communication from the Commissioner of Public Works and Transportation, be it

RESOLVED, that the Commissioner of Public Works and Transportation be and hereby is authorized to solicit bids by public advertisement on the following contract:

and be it further

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be receipt of a performance and payment bond in an amount equal to 100% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
