On January 2, 2019, three (3) bids were received and opened for Contract No. WCC-18-539 for Peekskill Janitorial Services, Westchester Community College, Valhalla, New York.

The two (2) apparent low bids were deemed non-responsive since they did not include bid bonds as required under the bid specifications. The sole responsive bid that was received was significantly over budget. Accordingly, the scope of the work will be adjusted to reflect budgetary constraints.

Therefore, it is respectfully requested that the sole responsive bid be rejected and the contract be readvertised as Contract No. WCC-18-539-Rev.

WHEREAS, upon review of the bids, the two (2) apparent low bids were deemed non-responsive since they did not include bid bonds as required under the bid specifications; and

WHEREAS, the sole responsive bid was significantly over budget. The scope of the work will be adjusted to reflect budgetary constraints; and

WHEREAS, it is requested that the sole responsive bid received for Contract No. WCC-18-539 be rejected and that Contract No. WCC-18-539 be re-advertised as Contract No. WCC-18-539-Rev for Peekskill Janitorial Services, Westchester Community College Valhalla, New York

#### NOW, THEREFORE, BE IT

RESOLVED, that it is in the best interest of the County of Westchester ("County") that all bids for Contract No. WCC-18-539, Peekskill Janitorial Services, Westchester Community College, Valhalla, New York be and are hereby rejected and that Contract No. WCC-18-539 be re-advertised as Contract No. WCC-18-539-Rev for Peekskill Janitorial Services, Westchester Community College, Valhalla, New York; and be it further

RESOLVED, that in lieu of a performance and payment bond, adequate and sufficient security for the faithful performance of this contract shall be the retainage of by the County of ten percent (10%) of all payments to the contractor for work completed. Upon the conclusion of each one (1) year period during the term of this Agreement, the contractor may request the release of said annual retainage upon the successful completion of all required work during that one (1) year period; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
