RE: Authorization is requested for the County of Westchester (the "County") to amend its agreement with the New York State Office for the Aging in which the County accepted a grant in the sum of \$1,096,876 in federal funding under Title III-B of the Older Americans Act to provide various support services for the Elderly, for the period commencing January 1, 2018 and terminating December 31, 2018, by increasing the total authorized not to exceed amount thereunder by \$6,792.

By resolution approved on February 1, 2018, (the "February 1st Resolution"), your Honorable Board authorized the County, acting by and through its Department of Senior Programs and Services (the "Department"), to enter into an Agreement with the New York State Office for the Aging ("NYSOFA") to accept a grant in an amount not-to-exceed \$1,096,876 in federal funding under Title III-B of the Older Americans Act to provide various support services for the Elderly (the "Title III-B Programs") for the period commencing January 1, 2018 and terminating December 31, 2018 (the "NYSOFA Agreement"). The NYSOFA Agreement was subsequently executed.

The Department was recently notified by NYSOFA that it intends to increase funding for the Title III-B Programs by \$6,792 thereby increasing the total amount authorized under the NYSOFA Agreement from \$1,096,876 to \$1,103,668. Accordingly, authority is now sought from your Honorable Board to amend the NYSOFA Agreement for the limited purpose of reflecting an increase in the not-to-exceed amount authorized thereunder by \$6,792, from \$1,096,876 to \$1,103,668.

Except as specifically amended hereby, all other terms and conditions of the NYSOFA Agreement shall remain in full force and effect.

Accordingly, I most respectfully recommend adoption of the attached proposed resolution.
