RE: Authority for the County of Westchester to enter into a Grant Agreement with the Federal Transit Administration ("FTA") for \$9,000,000.00 in Federal Transit Capital Assistance (Grant Agreement NY-2019-003-00).

Authority is requested for the County of Westchester (the "County") to enter into an agreement with the Federal Transit Administration ("FTA") for Federal Transit Capital Assistance in a grant totaling \$11,250,000.00 broken down as follows:

Funds received from this grant will be utilized as follows:

**Preventive Maintenance (\$9,000,000.00 Federal)**

These funds will be used to cover the cost of preventive maintenance for Westchester County's Bee-Line buses and related facilities. This includes general maintenance of the buses and garage facilities. Funds are for labor only and no materials will be purchased.

The goal of this project is to maintain buses and bus facilities that are vital to the operation of the Bee-Line Bus System.

The receipt of reimbursement funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.
