Rehabilitation of June Road Bridge Over Titicus River (BIN 1037480) Town of North Salem, New York

The 2019 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required for the rebabilitation of June Road Bridge over the Titicus River, which includes installing cofferdams for staged construction, providing concrete for repair of undermining to abutments and wing walls, removal of a silt bar and installation of grouted rip-rap along stream bank. This project also includes reshaping and constructing a grouted stone swale along the east edge of the roadway between the bridge and the existing culvert and miscellaneous concrete and railing repairs.

The objective of this contract is to repair substandard structural elements of the bridge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the June Road Bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
