RE: **Request for authority for the County of Westchester (the "County") to enter into a license agreement with OSG Mamaroneck, LLC (the "Licensor") pursuant to which the Licensor will permit the public to use a designated area of its parking lot as an overflow parking area for Saxon Woods Pool on weekends and holidays from June 29, 2019 through September 2, 2019.**

Authority is requested for your Honorable Board to authorize the County to enter into a License Agreement with the Licensor, which has an address at 900 Route 9 North, Suite 400, Woodbridge, New Jersey 07095 for the use of a designated area of Licensor's parking lot by the public attending Saxon Woods Pool on weekends and holidays from June 29, 2019 through September 2, 2019 at no cost to the County. The parking area, located at 1311 Mamaroneck Avenue, White Plains, New York, consists of approximately 300 parking spaces and shall be for passenger cars only. The County will provide an attendant while the parking lot is in use to oversee the lot and assure that it is maintained and kept free of debris. In addition, the County will indemnify and hold harmless the Licensor from and against any and all claims arising from the License.

The goal and objective of this license is to increase the availability of parking for the public using Saxon Woods Pool on summer weekends and holidays. This license promotes fiscal responsibility as it allows the County to meet parking demands at Saxon Woods Pool thereby increasing attendance and revenue at the park. This license will be monitored by the Parks Department to ensure compliance with all the terms of the agreement. This license is exempt from the procedures of the Procurement Policy under section 3(b) thereof.

A resolution authorizing a license agreement with the Licensor for the County's use of a designated area of its parking lot for overflow parking for Saxon Woods Pool on weekends and holidays during the 2019 pool season is attached for your favorable consideration.
