On May 1, 2019 six (6) bids were received and opened for Contract No. 19-506 for Rehabilitation of Bronx River Parkway and Two Bridges (BIN 3348999 and BIN 3348950), from the Cross County Parkway to Scarsdale Road, a Distance of 2.3 Miles, Cities of Mount Vernon and Yonkers, New York.

The bids were reviewed by the Department and it was determined that Arben Group LLC submitted the low bid in the amount of \$18,098,948.00.

The low bidder has been investigated and it has been found that Arben Group LLC:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving and to repair the substandard structural elements of two bridges.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Bronx River Parkway meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 19-506 be awarded to Arben Group LLC in the amount of \$18,098,948.00.
