Re: **Resolution Authorizing the County of Westchester to enter into a Film Permit with Random Productions, LLC to authorize filming at the Westchester County Center for two days from May 28, 2019 through May 29, 2019 for an estimated permit fee of \$39,968.75.**

Authority is requested for the County of Westchester, by and through its Office of Tourism & Film, to enter into a Film Permit with Random Productions, L.L.C. ("Random") in order for Random to utilize locations at the Westchester County Center, White Plains, New York to film the television series "The Plot Against America" for two days from May 28, 2019 through May 29, 2019. This request is being made because the film permit which authorizes an estimated fee of \$39,968.75, plus additional overtime costs for County personnel to be paid to the County, requires your Honorable Board's approval. This film permit will result revenue for the County and will also promote the County and provide revenue for local businesses.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board's approval of this agreement will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a film permit with Random is attached for your Honorable Board's approval.
