On June 12, 2019 the County of Westchester ("County") received and opened five (5) bids for Contract No. 17-502-Rev. for Rehabilitation of Anita Lane Utility Bridge and Stream Bank Improvements, Village of Mamaroneck, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Casabella Contracting of NY, Inc. submitted the low bid in the amount of \$365,578.85.

The low bidder has been investigated and it has been found that Casabella Contracting of NY, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to repair substandard structural elements of the bridge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Anita Lane utility bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 17-502-Rev. be awarded to Casabella Contracting of NY, Inc. in the amount of \$365,578.85.
