RE: Resolution authorizing the County of Westchester to amend a grant agreement with the State of New York to accept funding to educate voters and train poll workers, in order to extend the term of the agreement

Pursuant to a Resolution approved by your Honorable Board on January 18, 2007, the County of Westchester entered into a grant agreement with the State of New York to accept Voter Education/Poll Worker Training Funding in the amount of \$530,111 payable on a reimbursement basis, for the term commencing April 1, 2006 and terminating March 31, 2008, with the State's option to extend the contract for one additional year.

On June 12, 2008, your Honorable Board authorized a one-year extension to the agreement for the period from April 1, 2008 through March 31, 2009. On April 6, 2009 your Honorable Board authorized a second one-year extension to the agreement for the period April 1, 2009 through March 31, 2010. On February 18, 2010 your Honorable Board authorized a third one-year extension to the agreement for the period April 1, 2010 through March 31, 2011. On May 19, 2011 your Honorable Board authorized a fourth one-year extension to the agreement for the April 1, 2012 through March 31, 2013 term. On May 2, 2013 your Honorable Board authorized a fifth one-year extension to the agreement for the April 1, 2013 through March 31, 2014 term. On April 17, 2014 your Honorable Board authorized a sixth one-year extension to the agreement for the April 1, 2014 through March 31, 2015 term. On June 30, 2016 your Honorable Board authorized a seventh one-year extension to the agreement for the April 1, 2015 through March 31,

2016 term. On July 20, 2017 your Honorable Board authorized an eighth one-year extension to the agreement for the April 1, 2017 through March 31, 2018 term. On September 6, 2018 your honorable board authorized a ninth one-year extension to the agreement for the April 1, 2018 through March 31, 2019. All nine extensions were subsequently executed.

The State and the County now wish to further extend the term of the agreement for the period April 1, 2019 through March 31, 2020 so that unexpended grant funds may be utilized. All other terms and conditions of the agreement will remain unchanged.

The public purpose of this amendment is to implement programs to educate voters and poll workers on the new voting systems, including the ballot marking devices for voters with disabilities. Utilizing grant funding will alleviate the need for the use of County tax dollars for this purpose.

In order to take advantage of these grant funds your approval of the annexed proposed resolution is requested.

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute all appropriate contracts or documents necessary to effectuate the purposes of this resolution in the manner prescribed by law.
