RE: Authority for the County of Westchester to enter into a Grant Agreement with the Federal Transit Administration (“FTA”) for \$1,761,551.00 in Federal Transit Capital Assistance (Grant Agreement NY-2019-040-00).

Authority is requested for the County of Westchester (the “County”) to enter into an agreement with the Federal Transit Administration (“FTA”) for \$1,761,551.00 in Federal Transit Capital Assistance. A 50% County match is required to receive the FTA funds for a total of \$3,523,102.00 broken down as follows:

Federal Funds	50%	\$1,761,551.00
Local Funds	50%	<u>\$1,761,551.00</u>
<b>Total</b>		<b>\$3,523,102.00</b>

Funds received from this grant will be utilized as follows:

**Operation of ParaTransit Service Beyond 3/4 of a Mile from Fixed Route Service**  
**(\$1,761,551.00 Federal)**

These funds will be used to support operations of ParaTransit service for trips that serve eligible seniors and persons with disabilities who begin or end their trips more than 3/4 of a mile from existing Bee-Line fixed route service (outside the mandated complementary ADA corridor). Funding for this project is 50% Federal (\$1,761,551.00) and 50% Local (\$1,761,551.00) for a total of \$3,523,102.00.

The goal of this project is to maintain ParaTransit service and bus facilities that are vital to the operation of the overall Bee-Line bus system. If these grant funds are not accepted for the aforementioned project, ParaTransit service will be negatively impacted.

The receipt of reimbursement funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.
