On January 6, 2010, four (04) bids were received and opened for Contract No. 09-554 for Courthouse Plaza LED Lighting Upgrade, Richard J. Daronco Courthouse, White Plains, New York.

The bids were reviewed by the Department and it was determined that D & M Electrical Contracting, Inc. submitted the low bid in the amount of \$55,499.00.

The low bidder has been investigated and it has been found that D & M Electrical Contracting, Inc.:

- Performed satisfactory work in the past for the County.

The objective of this contract is to convert the Courthouse Plaza lighting to energy efficient LED fixtures.

This contract is in the public's best interest because it will promote the health and safety of the general public by maintaining proper plaza lighting levels while providing an energy savings by reducing energy consumption, thus addressing the County Executive's priority areas: Safety and Security (SS) and Fiscal Responsibility (FR).

If this resolution is not approved, the County will not realize the energy savings afforded by the installation of new LED fixtures.

The department will utilize Primavera Software Management tools to track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this contract will be made from Dormitory Authority, State of New York and Office of Court Administration (“DASNY/OCA”) Funds, not the County General Fund and will not impact the County tax levy.

It is my recommendation that Contract No. 09-554 be awarded to D & M Electrical Contracting, Inc. in the amount of \$55,499.00.
