Upon the conclusion of each one (1) year period during the term of this Agreement, the Contractor may request the release of said annual retainage upon the successful completion of all required work during that one (1) year period; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
