Re: **Resolution Authorizing the County of Westchester to enter into a Film Permit with NBCUniversal Media, LLC to authorize filming at Playland Park from February 12, 2020 through February 15, 2020 and on February 18, 2020 for an estimated permit fee of \$45,875.**

Authority is requested for the County of Westchester ("County"), by and through its Office of Tourism & Film, to enter into a Film Permit with NBCUniversal Media, LLC to utilize locations at the Playland Park, Rye, New York to film the television series "FBI" from February 12, 2020 through February 15, 2020 and on February 18, 2020. This request is being made because the film permit which authorizes an estimated fee of \$45,875 to be paid to the County, which includes estimated overtime costs for County personnel, requires your Honorable Board's approval. This film permit will result revenue for the County and will also promote the County and provide revenue for local businesses.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board's approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with NBCUniversal Media, LLC. is attached for your Honorable Board's approval.
