SUBJECT: Amending are solution that provided authority to solicit bids by public

> advertisement for transportation services for homeless pre-school and school-aged children for summer school, for a period of two (2) years and six (6) months commencing March 1, 2020, with the County having four (4) additional one (1) year options thereafter, by modifying the term of the contract to be solicited.

By a resolution approved on December 19, 2019 (the "Resolution"), your Honorable Board, authorized the County, acting by and through its Department of Social Services ("DSS"). to solicit bids by public advertisement for transportation services for homeless pre-school and school-aged children for summer school, for a period of two (2) years and six (6) months commencing March 1, 2020, with the County having four (4) additional one (1) year options thereafter.

Based upon its recent experiences, DSS has determined that it will have difficulty attracting an adequate level of interest and competition if this procurement is not aligned with the annual cycle on which such transportation contracts regularly operate within the school-related busing industry. Specifically, such contracts regularly start on a given September 1. Therefore, DSS has determined that it is most advisable for the contract to be bid under the abovementioned authority to be for a period of two (2) years, commencing September 1, 2020, with the County having four (4) additional one (1) year options thereafter.

Accordingly, it is respectfully requested that your Honorable Board amend the Resolution by modifying the first 'RESOLVED' clause by, a.) deleting the words "AND SIX (6) MONTHS" and, b.) changing "MARCH 1, 2020" to "SEPTEMBER 1, 2020".

By a separate resolution, DSS is requesting authority from your Honorable Board to extend to August 31, 2020 the term of the existing contract for these services.

Except as described above, all terms and conditions of the Resolution shall remain in full force and effect.
