On December 18, 2019 the County of Westchester ("County") received and opened nine (9) bids for Contract No. 16-513 for Rye Playland Parkway Path, Playland Parkway, North Street, Theodore Fremd Avenue, Purchase Street, Purdy Avenue and McCullough Place, City of Rye, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Peter J. Landi Inc. submitted the low bid in the amount of \$2,449,584.00.

The low bidder has been investigated and it has been found that Peter J. Landi Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to rehabilitate sidewalks and install new pathways at the Rye Playland Parkway Path.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the sidewalks and pathways at the Rye Playland Parkway Path meet current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 16-513 be awarded to Peter J. Landi Inc. in the amount of \$2,449,584.00.
