SUBJECT: Authorization to extend the term of Agreement No. 16-904 with Paul C. Rizzo Engineering – New York, PLLC retroactively from December 31, 2019 until December 31, 2021

Authority of your Honorable Board is requested to extend the term of Agreement No. 16-904 (the “Agreement”) between the County of Westchester (the “County”) and Paul C. Rizzo Engineering – New York, PLLC (the “Consultant”), 580 White Plains Road, Suite 425, Tarrytown, New York 10591, for the provision of engineering services associated with Rehabilitation of Various Dams, Westchester County, New York, retroactively from December 31, 2019 until December 31, 2021. The original Agreement was executed on March 18, 2016 and is for a total amount not to exceed \$187,845.00. The original Agreement completion date was December 31, 2019.

The engineering services included in the original Agreement are in progress. The County has been satisfied with the quality of services provided to date. The Consultant has spent a significant amount of time coordinating with the Department of Parks, Recreation and Conservation and the Department of Public Works and Transportation for this project. The design is still being developed and remaining tasks including preparation of final construction documents and bidding phase services will extend beyond the current Consultant Agreement completion date. Therefore, the professional services of the Consultant will be required beyond the original completion date in order to provide the remaining engineering services associated with this project. Attached is a Resolution requesting an extension of the Agreement retroactively from December 31, 2019 until December 31, 2021 with no increase in the not to exceed amount of \$187,845.00.

In addition, the County reserves the right to further amend this Agreement with the Consultant at a future date to provide for construction phase services, including but not limited to, design services during construction and project close-out services.

The objective of this term extension is in the County’s best interest as it will provide for uninterrupted professional services pursuant to the Agreement for the Department project contained herein.

Except as specifically amended hereby, all other terms and conditions of the Agreement will remain the same.

The Department of Public Works and Transportation will track scheduling and accomplishments by the Consultant and perform on-site inspections to ensure the successful completion of this project. It is recognized and understood that the County shall evaluate the performance of this contract by the Consultant and shall use such evaluation in deciding to award future contracts to the Consultant.

I urge your favorable consideration of the annexed proposed Resolution.

RESOLVED, that the County of Westchester (the "County"), acting by and through its Department of Public Works and Transportation, be and is hereby authorized to amend Agreement No. 16-904 (the "Agreement") with Paul C. Rizzo Engineering – New York, PLLC (the "Consultant"), 580 White Plains Road, Suite 425, Tarrytown, New York 10591, for the provision of engineering services associated with Rehabilitation of Various Dams, Westchester County, New York by extending the term retroactively from December 31, 2019 until December 31, 2021. In addition, the County reserves the right to further amend this Agreement with the Consultant at a future date to provide for construction phase services, including but not limited to, design services during construction and project close-out services; and be it further

RESOLVED, that all other terms and conditions of the Agreement, including the not to exceed amount of \$187,845.00 shall remain the same; and be it further

RESOLVED, that the County Executive or his duly authorized designee, is hereby authorized and empowered to execute any and all documents necessary and appropriate to effectuate the purposes hereof.
