Authority of your Honorable Board is requested for the County of Westchester to enter into an agreement with CSEA Local 860 to reimburse the County of Westchester for all salary and benefits costs related to the County's employment of CSEA member John Staino (the "Member") from December 30, 2019 when the Member became a County employee, and continuing for as long as the Member is employed by the County and is the CSEA Local 860 President.

The Member, who serves as President of CSEA Local 860, was employed by the Westchester Medical Center when his position was eliminated in 2019. The County hired the Member who is currently employed at the Department of Labs and Research. He is still the CSEA Local 860 President and desires to continue to have full union release time in order to perform his union duties.

Under the proposed agreement, CSEA Local 860 will reimburse the County on a quarterly basis for the entire cost of salary and benefits provided by the County to the Member. The term of the agreement will commence on December 30, 2019 when the Member became a County employee, and will continue for as long as the Member is employed by the County and is the CSEA Local 860 President
