RE: Authority to enter into a license agreement with Jeffrey C Bohr Inc., 1 Wasylenko Lane, Yonkers, New York 10701 for the operation of the golf professional concession at Dunwoodie Golf Course, Yonkers, New York for the period of January 1, 2021 through December 31, 2025, with the County having the sole option to extend the agreement for an additional five-year term.

Authority is requested to enter into a license agreement with Jeffrey C Bohr Inc. ("Bohr"), 1 Wasylenko Lane, Yonkers, New York 10701 for the operation of the golf professional concession at Dunwoodie Golf Course, Yonkers, New York for the period of January 1, 2021 through December 31, 2025 with the County having the sole option to extend the agreement for an additional five-year term, from January 1, 2026 through December 31, 2030.

The golf professional manages the golf cart operation, provides lessons and rents hand-pulled carts. In addition, the golf professional collects all golfer fees, including greens fees and golf cart fees and deposit them into a County account. For the privilege of operating the golf professional shop, Bohr will pay to the County the following annual license fees:

The County will pay Bohr a portion of all motorized golf cart rental fees for the first 25,000 motorized golf rounds as follows:

The remaining portion of the golf cart revenue shall be retained by the County as a license fee. Golf cart rental rates are set by the County each season and are currently \$20.00 per player for 18 holes and \$16.00 per player for 9 holes. In addition, pursuant to the terms of the license, Bohr shall keep all revenue derived from retail sales in the pro shop, golf lessons and the rental of hand-pulled carts.

If, at its sole option, the County decides to extend the agreement from January 1, 2026 through December 31, 2030, Bohr shall pay to the County the following annual license fees:

If, at its sole option, the County decides to extend the agreement from January 1, 2026 through December 31, 2030, the County will pay Bohr a portion of all motorized golf cart rental fees for the first 25,000 motorized golf rounds as follows:

The goal of this agreement is to provide revenue for the County and provide important services for golfers. The objective of this agreement will be tracked and monitored by observations and interactions with staff and site visits.

This agreement is exempt from the Westchester County procurement policy pursuant to Section 3(b), thereof.

Accordingly, approval of the attached resolution by your Honorable Board is most respectfully requested.

## RESOLUTION

Upon a communication from the Commissioner of Parks, Recreation and Conservation, be it hereby

**RESOLVED**, that the County of Westchester (“the County”) is hereby authorized to enter into a license agreement with Jeffrey C Bohr Inc. (“Bohr”), 1 Wasylenko Lane, Yonkers, New York 10701 for the golf professional concession at Dunwoodie Golf Course, Yonkers, New York for the period of January 1, 2021 through December 31, 2025; and be it further

**RESOLVED**, that the County may, at its sole option, extend the license for the period of January 1, 2026 through December 31, 2030; and be it further

**RESOLVED**, that for the privilege of operating the golf professional shop, Bohr will pay to the County the following annual license fees:

2025	\$17,000; and be it further

**RESOLVED**, that the County will pay Bohr a portion of all motorized golf cart rental fees for the first 25,000 motorized golf rounds as follows:

2021	\$9.00	\$6.00
2022	\$9.00	\$6.00

**RESOLVED**, that if, at its sole option, the County extends the license agreement from January 1, 2026 through December 31, 2030, Bohr will pay to the County the following annual license fees:

2028	\$19,000
2029	\$19,000
2030	\$20,000; and be it further

**RESOLVED**, that if, at its sole option, the County decides to extend the agreement from January 1, 2026 through December 31, 2030, the County will pay Bohr a portion of all motorized golf cart rental fees for the first 25,000 motorized golf rounds as follows:

2026	\$10.00	\$7.00
2027	\$10.00	\$7.00

**RESOLVED**, that the remaining portion of the golf cart revenue shall be retained by the County as a license fee; and be it further

**RESOLVED**, that the golf professional shall keep all revenue derived from retail sales in the pro shop, golf lessons and the rental of hand-pulled carts; and be it further

**RESOLVED**, that the County Executive or his authorized designee is hereby authorized to execute all instruments necessary to implement this Resolution.
