On May 14, 2020, your Honorable Board approved a resolution authorizing the County of Westchester ("County") to enter into an agreement with and the U.S. Department of Housing and Urban Development to Accept a grant under the Community Development Block Grant, HOME Investment Partnership Program and Emergency Solutions Grant in the total amount of \$4,978,089.00 for the term of May 1, 2020 to April 30, 2021.
