SUBJECT: Fourth Amendment to Agreement No. 07-932 in the matter of Engineering Services in connection with the Sprain Ridge Pool Modernization, Yonkers, New York

Consultant: CHA Consulting, Inc.
Amendment Amount: \$172,070.00

Pursuant to a Resolution approved on July 26, 2007, the County of Westchester ("County") entered into Agreement Number 07-932 ("Agreement") with Clough Harbour & Associates, LLP ("Consultant"), III Winners Circle, PO Box 5269, Albany, New York 12205, wherein the Consultant was to provide preliminary design services associated with the Sprain Ridge Pool Modernization, Yonkers, New York. The Agreement was thereafter amended by Resolution approved July 23, 2009, for final design services associated with the Sprain Ridge Pool Modernization, Yonkers, New York. The Agreement was thereafter further amended by Resolution approved February 6, 2016, to change the name of the Consultant to CHA Consulting, Inc. and for revised final design services associated with the Sprain Ridge Pool Modernization, Yonkers, New York. The Agreement was thereafter further amended by Resolution approved October 5, 2017, for additional design services and construction administration services associated with the main Competition Pool (Pool #2) at the Sprain Ridge Facility. The Agreement expired on December 31, 2019.

The engineering services included in the Agreement have been in progress. The County has been satisfied with the quality of services provided to date by the Consultant. Construction for this project began in July 2018 and was originally estimated to take ten (10) months to complete. Due to unforeseen field conditions, construction took approximately four (4) months longer than originally anticipated. Due to the extended construction time frame, additional construction administration services and design services during construction were necessary.

Authority of your Honorable Board is therefore requested to further amend the existing Agreement retroactively from December 31, 2019, to provide for additional construction administration services and design services during construction for the additional time during which construction activities have been extended in connection with the Sprain Ridge Pool Modernization, Yonkers, New York. For construction administration services, the Consultant shall monitor the construction procedures on the site to ensure compliance with the contract documents, coordinate scheduled activities of the contractors, submit construction progress reports and review and process contractors' applications for payment. In addition, the Consultant shall provide design services during construction consisting of shop drawing and submittal review, attendance at project meetings, periodic site visits and preparation of as-built drawings.

The objective of this project is to make improvements to the main Competition Pool including all infrastructure, site work, and landscaping at the Sprain Ridge Facility. These improvements are necessary to reopen the main Competition Pool to the public. This agreement will benefit the public as it meets the increased demand created by the rising popularity of aquatic recreation through modernizing the Sprain Ridge Pool with a safer, more sanitary facility.

The engineering discipline encompassed in this Amendment is not new, but rather, it is an integral part of the project that involves the same degree of skill, experience and complexity as the expertise generally described in the original project. Accordingly, this type of engineering discipline was originally contemplated in the Professional Prequalification Board and Professional Selection Board process.

The fee for the above services is for an amount of \$172,070.00 pursuant to an approved budget, bringing the total Agreement plus Amendments to \$2,471,770.00. The completion date of the Agreement shall be extended to June 30, 2021.

The Department of Public Works and Transportation will track scheduling and accomplishments by the Consultant and perform on-site inspections to ensure the successful completion of this project.

RESOLUTION

Upon communication from the Commissioner of Public Works and Transportation, be it hereby

RESOLVED, that the existing Agreement between the County of Westchester (“County”) and CHA Consulting, Inc. (“Consultant”), III Winners Circle, PO Box 5269, Albany, New York 12205, be amended retroactively from December 31, 2019, to provide for additional construction administration services and design services during construction for the additional time during which construction activities have been extended in connection with the Sprain Ridge Pool Modernization, Yonkers, New York. For construction administration services, the Consultant shall monitor the construction procedures on the site to ensure compliance with the contract documents, coordinate scheduled activities of the contractors, submit construction progress reports and review and process contractors’ applications for payment. In addition, the Consultant shall provide design services during construction consisting of shop drawing and submittal review, attendance at project meetings, periodic site visits and preparation of as-built drawings; and be it further

RESOLVED, that for the additional services rendered in accordance with the Consultant’s proposal, CHA Consulting, Inc., shall be paid a fee of \$172,070.00 pursuant to an approved budget, increasing the total maximum fee to \$2,471,770.00; and be it further

RESOLVED, that the completion date of the Agreement shall be extended to June 30, 2021; and be it further

RESOLVED, that all other provisions of the existing Agreement shall remain in full force and effect; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
