On July 22, 2020 the County of Westchester ("County") received and opened four (4) bids for Contract No. 19-533 for Resurfacing and Related Improvements, South Broadway and Post Road (C.R. #108), between Main Street and Mamaroneck Avenue, a Distance of 0.38 Miles, City of White Plains, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that ELQ Industries, Inc. submitted the low bid in the amount of \$1,058,870.00.

The low bidder has been investigated and it has been found that ELQ Industries, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that South Broadway and Post Road meet current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 19-533 be awarded to ELQ Industries, Inc. in the amount of \$1,058,870.00.
