On July 15, 2020 the County of Westchester ("County") received and opened twenty (20) bids for Contract No. 20-508 for Various Paving and Drainage Improvements, South County Trailway, Barney Street, Yonkers to Main Street, Elmsford, Westchester County, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that MPCC Corp. submitted the low bid in the amount of \$3,113,323.00.

The low bidder has been investigated and it has been found that MPCC Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to improve paving and drainage along the South County Trailway.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
