Re: Request for authority to enter into an agreement with the State of New York,

acting by and through the New York State Department of Health, to accept a grant in the amount of \$120,000 for the Department of Laboratories and Research to be reimbursed for providing SARS-CoV-2/COVID-19testing for the term 5/18/20 -

5/17/21.

Authority is requested for the County of Westchester, acting by and through the Department of Laboratories & Research (the "Department"), to enter into an agreement with the State of New York, acting by and through the New York State Department of Health ("NYSDOH"), to accept a grant in the amount of \$120,000 for the Department to be reimbursed the costs of providing SARS-CoV-2/COVID-19 testing (the "Grant") for the period from 5/18/20 through 5/17/21 (the "Agreement"). The grant is being administered through Health Research, Inc., the contractor of the NYSDOH.

The NYSDOH awarded the Grant because the Departments' Public Health Laboratory is the only lab in the region that is approved as a Laboratory Response Network ("LRN") Reference laboratory by NYSDOH and the Centers for Disease Control ("CDC"), and is approved to receive LRN assays provided by the CDC. The Department participates in proficiency testing through the LRN as well as the Quality Assurance Program provided by the Wadsworth Center and maintains the capability to accept samples 24/7/365 for laboratory testing when required during a public health emergency and/or requested by law enforcement. The Department will also provide scientific and technical guidance to their local labs regarding SARS-CoV-2/COVID-19 specimen collection, packaging, transport, testing and reporting, and assist with compliance related issues.

The proposed Grant will provide reimbursement to the County for SARS-CoV-2/COVID-19 testing and related costs. The Grant funds will enable the Department to cover expenses related to providing necessary testing during the current COVID-19 public health emergency.

The Agreement will serve a public purpose by enhancing the quality of SARS-CoV-2/COVID-19 specimen collection, packaging, transport, testing and reporting during the pandemic.

Entering into the proposed Agreement is in best interests of the County because during the current public health emergency, increasing the SARS-CoV-2/COVID-19 testing availability in Westchester County will provide information necessary to end the pandemic.

The Grant will be tracked and monitored through quarterly progress reports provided to the granting authority.

As this Agreement does not constitute a procurement of goods or services, the provisions of the Westchester County Procurement Policy are not applicable.
