On August 26, 2020 the County of Westchester ("County") received and opened one (1) bid for Contract No. 19-505 for Fire Suppression System Upgrades, Playland Park, Rye, New York.

One (1) contractor submitted a bid for this project. The project was advertised on the Empire State Purchasing Group website, in addition to the Journal News (Westchester-Putnam Edition), and was viewed by forty seven (47) entities on the Empire State Purchasing Group website. In addition, emails were sent to those forty seven (47) entities and to an additional seven hundred twenty one (721) suppliers and contractors.

The bid was reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Mace Contracting Corporation, a MBE firm, submitted the sole bid in the amount of \$1,647,000.00, and has proposed the utilization of the following subcontractors: Filingeri Electrical Contracting Corp. (Electrical Work), 3510 Lexington Avenue, Mohegan Lake, New York 10547; and SRI Fire Sprinkler LLC (Installation of Dry Pipe Sprinkler Systems), 1060 Central Avenue, Albany, New York 12205.

The sole bidder has been investigated and it has been found that Mace Contracting Corporation:

The objective of this contract is to install fire sprinkler systems in the following rides and attractions: the Dragon Coaster station, the Old Mill, the Cross Axis games buildings, the Carpenter Shop and the Commissary.

This contract is in the public's best interest because it will ensure that all facilities at Playland Park meet current fire codes and requirements.

The Department will track scheduling and accomptishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 19 505 be awarded to Mace Contracting Corporation in the amount of \$1,647,000.00.
