On August 19, 2020 the County of Westchester ("County") received and opened seven (7) bids for Contract No. 20-523 for Resurfacing and Related Improvements, Park Avenue (C.R. #38), from Harrison Avenue to Boston Post Road, a Distance of 0.64 Miles, Town of Harrison and City of Rye, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Westchester Hills Landscaping Inc. submitted the low bid in the amount of \$1,080,938.17.

The low bidder has been investigated and it has been found that Westchester Hills Landscaping Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Park Avenue meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 20-523 be awarded to Westchester Hills Landscaping Inc. in the amount of \$1,080,938.17.
