Re: Request for Authorization to Settle the Claim of <u>Douglas Terranova against the County</u>

of Westchester in the amount of \$22,500.00.

Attached for your consideration is a resolution that, if approved by your Honorable

Board, would authorize settlement of the claims related to the action of <u>Douglas Terranova</u> ("Plaintiff") against the County of Westchester in the amount of \$22,500.00¹.

On November 21, 2016, at about 7:40 a.m., the plaintiff was walking on the sidewalk on the Green Acres Avenue Bridge (the "Bridge") in Scarsdale toward the Hartsdale Train Station when he claims he noticed an accumulation of ice along the sidewalk. At that point he decided to walk in the street. After taking about five (5) steps in the street plaintiff slipped and fell on ice. The Bridge is owned by the County and both the sidewalk and street surface of the Bridge are maintained by the County.

Plaintiff was removed from the accident scene by ambulance and transported to White Plains Hospital Emergency Room. Plaintiff had suffered a total dislocation of his left femoral prosthetic hip which was relocated in the emergency room.

The County retained an orthopedic physician to review the Plaintiff's medical records and perform a physical examination of Plaintiff to determine the extent of the injuries claimed as a result of this accident. The County's expert confirmed that Plaintiff suffers chronic instability and pain at his left hip resulting in an affected gait that was not present before the accident. Plaintiff also now requires a cane to stabilize his gait otherwise he walks with a limp, also not present before the accident.

The County filed a motion for summary judgment seeking to dismiss plaintiff's claims. However, that motion was denied as the Court found issues of fact requiring a trial for

determination of same. Considering the totality of circumstances surrounding this case, this Fu. ne Deponeur with a contract. Anna 200 Me office believes it is in the best interest of the County to settle with the Plaintiff. Further, the Commissioners for the Department of Public Works and Transportation and the Department of Parks Recreation and Conservation have been advised of this matter and concur with the
