SUBJECT: Resolution Authorizing the Agreement Between the County of Westchester and

Westhab, Inc., for a Homeless Prevention and Rapid Rehousing Program (HPRP) to Administer the Medium Term Rental Assistance Payments to Facilitate the Disbursement

of Rental Subsidies to Landlords on Behalf of the HPRP Clients

The attached resolution authorizes the County of Westchester to enter into an agreement with Westhab, Inc. to provide a grant from the Emergency Shelter Grant Program under the American Recovery and Reinvestment Act of 2009. The grant will be used for a Homeless Prevention and Rapid Rehousing Program providing medium term rental assistance payments to facilitate the disbursement of rental subsidies to landlords on behalf of the HPRP clients for the 18 month term that the clients are eligible for assistance. The amount of the grant is \$435,417.00, and the term is March 1, 2010, to December 31, 2011.

Westhab was founded in 1981 by a group of real estate professionals and activist clergy frustrated by the growing affordable housing crisis in Westchester County. A partnership with the Westchester County Department of Social Services led to the development of a new method of housing the homeless – using public assistance funds to preserve and expand good, low-income housing rather than continuing to pay for expensive and inadequate motel shelter. In the early 1990's the County asked Westhab to renovate and operate shelters. Westhab manages four shelters and continues to develop permanent affordable housing. They also provide employment training and youth services programs. Westhab is Westchester County's leading provider of housing and supportive services for low-income populations.

The agreement will serve the public purpose of helping to prevent homelessness in the Westchester County Consortium communities and promote fiscal responsibility.

The goal and objective of this agreement is to administer medium term rental assistance payments that will disburse rental subsidies to landlords on behalf of HPRP clients for 18 months. The clients are low-income families in imminent danger of becoming homeless within the Westchester Urban County Consortium communities and if necessary, residents from non-consortium communities can be assisted provided that funding is available to address this population. The agreement exhibits fiscal responsibility by providing funds from non-County sources. The program will be monitored by the Westchester County Department of Planning staff, who will review all payment requests to ensure all contractual requirements are met.

Should the agreement not be authorized, at least 65 persons will not receive the rent subsidies, thus these low income families may become homeless.

The Department of Planning issued a public Request For Proposals (RFP) on July 10, 2009, seeking nonprofit housing agencies to provide eviction and homeless prevention services under three different funding programs. In accordance to the County of Westchester's Procurement Policy and Procedures, the RFP was posted on the County's website, posted on the Housing List Serve, and an e-mail was sent to twenty-eight (28) local agencies. As of August 3, 2009, eight (8) agencies submitted proposals (See Attachment 1) for the Homeless Prevention and Rapid Re-Housing Program (HPRP). Westhab, Inc., was the only agency that submitted a proposal under the rapid re-housing piece under the HPRP Program.

Act #9-2008 was adopted February 4, 2008, by the Westchester County Board of Legislators and approved May 8, 2008, by the Board of Acquisition and Contract. This act authorizes the County of Westchester to accept and administer an approximately \$1,252,466.00 grant under the Emergency Shelter Grant Program from the United States Department of Housing and Urban Development. This project will be funded from this fiscal year.

I recommend approval of this agreement.

RESOLUTION

UPON A COMMUNICATION FROM THE ACTING COMMISSIONER OF PLANNING, BE IT HEREBY

RESOLVED, That the County of Westchester is hereby authorized to enter into an agreement with Westhab, Inc., through the Emergency Shelter Grant Program, in the amount of \$435,417.00 pursuant to an approved budget, for a period beginning March 1, 2010, and ending December 31, 2011, to conduct an HPRP –Medium Term Rental Subsidy Program for the benefit of the Westchester Urban County Consortium communities and non-consortium residents, if necessary. The program will include, but is not limited to, providing medium term rental assistance payments to facilitate the disbursement of rental subsidies to landlords on behalf of the HPRP clients for 18 months. It is anticipated that at least 65 persons will participate in this program, and be it further
