SUBJECT: Authority to exercise the County's option to extend the term of an agreement with Gentech Ltd. for one two (2) year option period, thereby increasing the amount of the agreement by \$468,200.00 and extending the term of the agreement through July 31, 2024. (Contract No. 19-203)

By Resolution approved on June 13, 2019 (the "June 13th Resolution"), your Honorable Board awarded Contract No. 19-203 to Gentech Ltd. ("Gentech"). The June 13th Resolution authorized the County of Westchester (the "County") to enter into Contract No. 19-203 with Gentech, pursuant to which Gentech was to provide Emergency Generator Service, Various Locations Westchester County, New York for the amount of \$702,300.00 for the period of August 1, 2019 through July 31, 2022, ("Contract No. 19-203" or the "Agreement"), with the County having the sole option to extend the Agreement for one (1) two (2) year option period.

The County now seeks authority from your Honorable Board to 1) exercise the two (2) year renewal option and extend the termination date of the Agreement from July 31, 2022 to July 31, 2024; and 2) increase the amount of the Agreement by \$468,200.00 from an amount of \$702,300.00 to a new total amount not to exceed \$1,170,500.00.

All other terms and conditions of the June 13, 2019 Resolution and the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing a safe and code compliant work environment at various County facilities in the event of a power failure.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

RESOLVED, that the County of Westchester is authorized to 1) exercise its two (2) year renewal option for Contract No. 19-203 with Gentech Ltd., 3017 US Route 9W, New Windsor, New York 12553, to provide Emergency Generator Service, Various Locations, Westchester County, New York and extend the termination date of the Agreement from July 31, 2022 to July 31, 2024; and 2) increase the amount of the Agreement by \$468,200.00 from an amount of \$702,300.00 to a new amount not to exceed \$1,170,500.00; and be it further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the June 13, 2019 Resolution and the Agreement shall remain in full force and effect and unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
