Re: Authority for the Westchester Community College to enter into affiliation agreements with: (i) the Hebrew Home for the Aged at Riverdale dba Hebrew Home at Riverdale for a Social Work Program as part of the College's Education & Human Services Department, for a term commencing on or about September 1, 2021 and continuing in full force and effect unless terminated by either party upon written notice; and (ii) ARC Rockland for a Social Work Program as part of the College's Education & Human Services Department, for a term of three years commencing on or about January 3, 2022, unless terminated by either party upon written notice, at no cost to the College.

Westchester Community College (the "College"), through its School of Business and Professional Careers offers a program in Social Work. The College offers supervised education and instruction for matriculated Westchester Community College students who are pursuing a degree or certificate in conjunction with various organizations.

Authority is hereby requested to enter into affiliation agreements with the following entities for supervised laboratory/clinical education and instruction for College Students (hereinafter collectively referred to as the "Providers")

1. Hebrew Home for the Aged at Riverdale dba Hebrew Home at Riverdale for a Social Work Program as part of the College's Education & Human Services Department, for a term commencing on or about September 1, 2021 and continuing in full force and effect unless terminated by either party upon written notice;
2. ARC Rockland for a Social Work Program as part of the College's Education & Human Services Department, for a term of three

years commencing on or about January 3, 2022, unless terminated by either party upon written notice.

There will be no cost to the College in connection with these agreements, however, in accordance with the terms of the agreements, the College shall agree to defend, indemnify and hold harmless the facilities for the acts of its students and College instructors.

I believe that it is in the best interest of the College to provide clinical education and instruction programs, and I, therefore, recommend that you act favorably on the annexed proposed resolution.

## RESOLUTION

Upon a communication from the President of Westchester Community College, be it hereby

**RESOLVED**, that the County of Westchester, acting by and through Westchester Community College (the "College"), is hereby authorized to enter into affiliation agreements with the following entities for supervised laboratory/clinical education and instruction for matriculated College Students (hereinafter collectively referred to as the "Providers"):

1. Hebrew Home for the Aged at Riverdale dba Hebrew Home at Riverdale for a Social Work Program as part of the College's Education & Human Services Department, for a term commencing on or about September 1, 2021 and continuing in full force and effect unless terminated by either party upon written notice;
2. ARC Rockland for a Social Work Program as part of the College's Education & Human Services Department, for a term of three years commencing on or about January 3, 2022, unless terminated by either party upon written notice; and be it further

**RESOLVED**, that there will be no cost to the College in connection with these agreements, however, in accordance with the terms of the agreements, the College shall agree to defend, indemnify and hold harmless the Providers for the negligent acts of its students and College instructors; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all instruments and to take all action necessary to implement the purposes hereof.
