On March 31, 2010, five (05) bids were received and opened for Contract No. 09-557 for Resurfacing and Related Improvements, Hamilton Avenue (C.R. No. 52) At the Intersection of North Broadway, City of White Plains, New York.

The bids were reviewed by the Department and it was determined that McNamee Construction Corp. submitted the low bid in the amount of \$232,550.00.

The low bidder has been investigated and it has been found that McNamee Construction Corp.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving, thus addressing the County Executive's priority area: Safety and Security (SS).

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Hamilton Avenue meets current codes and standards as well as reducing the County's annual maintenance costs.

The project will provide an environmental benefit by eliminating flooding conditions due to damaged drainage structures.

If this resolution is not approved, the existing substandard pavement areas will continue to deteriorate, resulting in more costly repairs or, possibly, complete replacement in the future.

The department will utilize Primavera Software Management tools to track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 09-557 be awarded to McNamee Construction Corp. in the amount of \$232,550.00.
