SUBJECT: Request for authority for the County of Westchester to enter into an agreement with United Charitable f/b/o Re-Entry Link Charitable pursuant to which the contractor will provide a summer intensive for up to twenty (20) at-risk and justice involved youth between the ages of 14-17 years old residing in the City of Mount Vernon, for the period from January 1, 2022 through December 31, 2022 for an amount not-to-exceed \$36,018.00.

Authority is respectfully requested for the County of Westchester ("County") to enter into an agreement with United Charitable f/b/o Re-Entry Link Charitable ("United Charitable") pursuant to which United Charitable will provide a summer intensive for up to twenty (20) at-risk and justice involved youth between the ages of 14-17 years old residing in the City of Mount Vernon, for the period from January 1, 2022 through December 31, 2022 for an amount not-to-exceed \$36,018.00, payable half upon contract execution, and half on or about September 1, 2022.

The 6-week intensive will take place, 3 days per week, from July 11 to August 19, 2022 at the Double Door event space located at 29 Elm Street, Mount Vernon, NY 10550. Youth participants will receive mentorship and guidance, life skills training, wellness interventions and classroom instruction on video production and audio engineering with experiential field trips which could lead to internships and employment opportunities after program completion.

The proposed agreement will serve a public purpose by providing youth already exposed to the justice system with opportunities for growth that will lead to prosocial and law-abiding behavior.

This procurement is exempt from the requirements of the County Procurement Policy pursuant to Section 3(a)(xviii) thereof.

Accordingly, I most respectfully recommend approval of the attached Resolution.

RESOLUTION

Upon a communication from the Chairwoman of the Westchester County Board of Legislators, it is hereby:

RESOLVED, that the County of Westchester ("County") is hereby authorized to enter into an agreement with United Charitable f/b/o Re-Entry Link Charitable ("United Charitable") pursuant to which United Charitable will provide a summer intensive for up to twenty (20) at-risk and justice involved youth between the ages of 14-17 years old residing in the City of Mount Vernon, for the period from January 1, 2022 through December 31, 2022 for an amount not-to-exceed \$36,018.00, payable half upon contract execution, and half on or about September 1, 2022; and be it further

RESOLVED, that this Agreement is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the Contractor, then the Contractor shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the Chairwoman of the Westchester County Board of Legislators, or her duly authorized designee, is hereby authorized to execute any documents and take such actions reasonably necessary and appropriate to effectuate the purposes of this Resolution.
