SUBJECT: **Authority for the County of Westchester to amend an agreement with RM Friedland, LLC for the provision of various real estate services to the County, for a one (1) year term commencing upon execution, by extending the term of the agreement from May 12, 2023 through May 11, 2024 and to further authorize RM Friedland, LLC to continue to subcontract a portion of the services to Sky Queen Realty, 126 Tower Road, Suite 290, West Harrison, NY 10604, during the extension term.**

By resolution approved on May 12, 2022 (the “May 12th Resolution”), your Honorable Board authorized the County of Westchester (“County”) to enter into an agreement with the real estate firm of RM Friedland, LLC (“RMF”), pursuant to which RMF would provide various real estate services, including brokerage services, to assist the County in realizing efficiencies, synergies, and possible cost savings through better management of its real property and other real estate expenditures, for a one (1) year term commencing upon execution thereof by both parties and approval of same by the Office of the County Attorney, payable at the rates set forth in Schedule “A”, attached to the May 12th Resolution, in an amount not-to-exceed \$50,000, plus commissions (the “Agreement”). The May 12th Resolution further authorized RMF to subcontract a portion of the services to Sky Queen Realty, 126 Tower Road, Suite 290, West Harrison, NY 10604. The Agreement was subsequently executed on May 12, 2022.

The parties now desire to amend the Agreement in order to extend the term thereof for an additional year, commencing on May 12, 2023 and continuing through May 11, 2024. Accordingly, authority is hereby requested to amend the Agreement with RMF for the provision of various real estate services to the County, in order to extend the term thereof for an additional year, from May 12, 2023 through May 11, 2024. Authority is further requested to authorize RMF to continue to subcontract a portion of the services to Sky Queen Realty, 126 Tower Road, Suite 290, West Harrison, NY 10604, during the extended term.

Except as otherwise specifically amended hereby, all remaining terms and conditions of the Agreement shall remain in full force and effect upon the parties.

Exemption of this amendment to the Agreement with RMF from the requirements of the Westchester County Procurement Policy has been granted by your Honorable Board pursuant to a separate resolution of even date herewith.

I respectfully recommend the adoption of the attached Resolution.

RESOLUTION

Upon a communication from the Director of the Office of Countywide Administrative Services & Real Estate, be it hereby

RESOLVED, that the County of Westchester (the “County”) is hereby authorized to amend an agreement with RM Friedland, LLC (“RMF”) (the “Agreement”), pursuant to which RMF agreed to provide the County with various real estate services, including brokerage services, to assist the County in better management of its real property, for a one (1) year term commencing upon execution of the Agreement by both parties and approval of same by the Office of the County Attorney, payable at the rates set forth in Schedule “A”, attached to the Agreement, not to exceed the sum of \$50,000, plus commissions, by extending the term of the Agreement for an additional year commencing on May 12, 2023 and continuing through May 11, 2024; and be it further

RESOLVED, that RMF is hereby further authorized to continue to subcontract a portion of the services to Sky Queen Realty, 126 Tower Road, Suite 290, West Harrison, NY 10604, during the extended term; and be it further

RESOLVED, that except as otherwise specifically amended hereby, all other terms and conditions of the Agreement shall remain in full force and effect upon the parties; and be it further

RESOLVED, that the County Executive or his duly authorized designee is empowered to execute all documents and take all actions necessary to effect the purpose of this resolution.
