RE: Authorization to Enter into Contract with the New York State Department of Health to Accept Continued Funding for the Preventive Dental Services Program Grant

Multi-year Grant: July 1, 2006 – June 30, 2011
Fifth Budget Period: July 1, 2010 – June 30, 2011
Budget Amount: Not-To-Exceed \$54,500

The Westchester County Department of Health (“WCDH”) seeks authorization to enter into contract with the New York State Department of Health (“NYSDOH”) to accept continued funding for the Preventive Dental Services Program grant from 7/1/06 – 6/30/11, for the fifth budget period July 1, 2010 through June 30, 2011, pursuant to an approved budget, in the not-to-exceed amount of \$54,500.

The public purpose is to promote the public health and general welfare of the County by providing essential preventive dental services to low-income elementary school children.

The goals and objectives of the program are to provide early and preventive dental screenings and oral prophylaxis, sealant applications, oral health presentations and to distribute educational materials to elementary school-aged children in the low-income areas of Yonkers.

This program is monitored and tracked by recording all services provided and reporting activity on a quarterly basis to the NYSDOH.

Approximately 500 underserved children will receive dental screenings and oral prophylaxis and 600 sealants will be applied.

Your approval of the attached resolution is respectfully requested.
