The 2010 Operating Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to remove and replace the existing sliding entrance doors at the Terminal. The project also includes installation of new air curtains at each entrance.

The objective of this contract is to maintain the operation of the sliding door assemblies.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Airport Terminal entrance systems function within operating specifications.

The project will provide energy savings by installing energy efficient air curtains at each entrance, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this entire contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.
