The objective of this contract is to maintain the weather tightness of the Saxon Woods Pool Filter Building and the Ward Pound Ridge Maintenance Garage.

This project will provide an environmental benefit by meeting current New York State Energy Codes resulting in a reduction in energy consumption, thus addressing the County Executive's priority area: Health and the Environment (HE).
