Re: Authorizing the County of Westchester to exercise the first renewal option of an agreement with Aramark Correctional Services, LLC for the operation of inmate

commissaries for the term from January 1, 2010 through December 31, 2010

By Resolution approved on March 5, 2009, your Honorable Board authorized the County of Westchester to enter into a license agreement with Aramark Correctional Services, Inc. to operate inmate commissaries at the Westchester County Jail, the Penitentiary, the Female Division and Ward 29 at the Westchester Medical Center for the term January 1, 2009 through December 31, 2009 with the County's option to renew the agreement for up to four (4) one (1) year periods. On June 11, 2009, your Honorable Board amended the prior Resolution to reflect the correct name of the contractor as Aramark Correctional Services, LLC ("Aramark").

Authority is now requested for the County to exercise the agreement's first renewal option for the term January 1, 2010 through December 31, 2010. In accordance with the agreement, Aramark's commission paid to the County will increase from 33.1% of net sales to 34.1% of net sales.

The goal and objective of this contract is to provide and distribute commissary goods to be purchased by the inmates (a population of 1300 - 1600) in the most professional and cost efficient manner possible. The commissary items should be known to be popular and generally acceptable to the inmates.

There will be a verifiable audit trail. The contractor will provide a commissary trust balance sheet that is maintained by the Department of Correction, and an inmate order history. The contractor will also provide a commissary sales and commissary report that itemizes each individual sale which confirms sales and commissions.
