On August 18, 2010, seven (07) bids were received and opened for Contract No. 09-552 for Painting and Signage Improvements, White Plains Bus Terminal, White Plains, New York.

The bids were reviewed by the Department and it was determined that Titan Improvement Corp. submitted the low bid in the amount of \$140,375.00.

The low bidder has been investigated and it has been found that Titan Improvement Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

 Non-Recurring Budget
 Operating Budget

The objective of this contract is to clean and repaint the terminal along with providing a color coded identification system for the bus lanes.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the White Plains Bus Terminal meets standards for pedestrian safety, thus addressing the County Executive's priority area: Safety and Security (SS). There are no energy or environmental components associated with this project.

This Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

Payment for this contract will be made from American Recovery and Reinvestment Act of 2009 (ARRA) funds, not the County General Fund and will not impact the County tax levy.

It is my recommendation that Contract No. 09-552 be awarded to Titan Improvement Corp. in the amount of \$140,375.00.
