Re: **Resolution authorizing the County of Westchester to enter into an agreement with Bargaining Associates for the provision of consulting services to Westchester Community College in connection with labor negotiations and related matters for the term from September 1, 2010 through August 31, 2011 for an amount not to exceed \$78,000 payable at an hourly rate of \$200 pursuant to an approved budget**

Authority is requested to enter into an agreement with Bargaining Associates for the provision of consulting services to Westchester Community College in connection with labor negotiations and related ongoing contractual matters including, without limitation, arbitrations, grievances, unfair labor practices, improper practice charges and labor management committee meetings. The term of the agreement will be from September 1, 2010 through August 31, 2011 for an amount not to exceed \$78,000 payable at an hourly rate of \$200, pursuant to an approved budget.

Your Honorable Board approved the exemption of this proposed agreement in accordance with Section 3 (a) xxi of the County's Procurement Policy.

Given Mr. Wittenberg's vast experience and familiarity with County labor practices and procedures, it would serve the public interest for his firm to provide consulting services to Westchester Community College in connection with labor negotiations and related matters. Accordingly, approval of the annexed proposed Resolution is requested.
