On September 22, 2010, nine (09) bids were received and opened for Contract No. 09-544 for Final Closure, Sprout Brook Residue Disposal Facility, Cortlandt Manor, New York.

The bids were reviewed by the Department and it was determined that Bilotta Construction Corp. submitted the low bid in the amount of \$5,781,302.10.

The low bidder has been investigated and it has been found that Bilotta Construction Corp.:

Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to allow the Department of Environmental Facilities to complete the closure of the Sprout Brook Residue Disposal Facility.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing the environmental benefit of containing leachate and gases associated with landfill closures, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 09-544 be awarded to Bilotta Construction Corp. in the amount of \$5,781,302.10.
