On September 22, 2010, four (04) bids were received and opened for Contract No. 10-220 for Replacement of Entrance Doors, Terminal Building, Westchester County Airport, Towns of Harrison and North Castle and Village of Rye Brook, New York.

The bids were reviewed by the Department and it was determined that Vezandio Contracting Corp. submitted the low bid in the amount of \$151,500.00.

The low bidder has been investigated and it has been found that Vezandio Contracting Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

Funds for this project are available in the:

The objective of this contract is to maintain the operation of the sliding door assemblies.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Airport Terminal entrance systems function within operating specifications.

The project will provide energy savings by installing energy efficient air curtains at each entrance, thus addressing the County Executive's priority area: Health and the Environment (HE).

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 10-220 be awarded to Vezandio Contracting Corp. in the amount of \$151,500.00.

Payment for this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.
