RE: **RESOLUTION AUTHORIZING THE COUNTY OF WESTCHESTER TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES IN AN AMOUNT NOT TO EXCEED \$338,000 IN STATE FUNDS FOR THE DISTRICT ATTORNEY'S OFFICE TO OPERATE THE CRIMES AGAINST REVENUE PROSECUTION PROGRAM FOR THE PERIOD OCTOBER 1, 2010 THROUGH SEPTEMBER 30, 2011, PURSUANT TO AN APPROVED BUDGET**

Authority is sought for the County of Westchester to enter into an agreement with the New York State Division of Criminal Justice Services in an amount not to exceed \$338,000 in State Funds for the District Attorney's Office to operate the Crimes Against Revenue Prosecution Program, for the period October 1, 2010 through September 30, 2011, payable pursuant to an approved budget.

The general welfare of the citizens of the County is served by the goals of this program which are to enhance a Crimes Against Revenue Prosecution Program by investigating and prosecuting those who violate tax laws, reclaim lost revenue, and increase voluntary compliance with applicable laws. The goals and objectives of the CARPS program are monitored by the District Attorney's Office and quarterly progress reports are submitted to DCJS for their review and approval.

The requirements of the Westchester County Procurement Policy were followed; the procurement is exempt under Section 3(a)iii of the Procurement Policy which provides for the exception "Transactions or contracts with the United States of America, any state..., agency...". The agreement is a transaction/contract with the New York State Division of Criminal Justice Services.

Wherefore, authority is respectfully sought for the County to enter into this agreement.

**RESOLUTION**

Upon a communication from Janet DiFiore, District Attorney, be it hereby,

**RESOLVED**, that authority is granted to the County of Westchester to enter into an agreement with the New York State Division of Criminal Justice Services in an amount not to exceed \$338,000 in State Funds for the District Attorney's Office to operate the Crimes Against Revenue Prosecution program for the period October 1, 2010 through September 30, 2011, payable pursuant to an approved budget; and it is further,

**RESOLVED**, that the District Attorney or her duly authorized designee be and hereby is authorized and empowered to execute this agreement for the County of Westchester.
