RE: AUTHORITY FOR THE COUNTY OF WESTCHESTER TO ENTER INTO A GRANT AGREEMENT WITH THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION TO ACCEPT A GRANT IN THE AMOUNT OF \$1,375,000.00 TO FINANCE THE OPERATION OF THE "WESTCHESTER SHUTTLE NETWORK" FOR THE PERIOD OCTOBER 1, 2009 THROUGH SEPTEMBER 30, 2010

Authority is requested for the County of Westchester to enter into an agreement with the New York State Department of Transportation to accept grant funds totaling \$1,375,000.00 (comprised of 80% Federal STPX - \$1,100,000.00, and 20% State SDF - \$275,000.00) for services provided during the period October 1, 2009 through September 30, 2010. Funding from this agreement will be applied to the following:

The New York State Department of Transportation has developed a long-term program to fund and coordinate Regional Transit services. The specified bus services are eligible for participation in the program. There will be no change in present bus operations and there will be no cost to the County other than the cost of service operation which is subject to appropriation.

The goal of this agreement is to provide reimbursement for expenses the County has incurred in the operation of bus service and passenger information from October 1, 2009 through September 30, 2010. The purpose of the State program is to reduce traffic congestion by encouraging the use of transit as an alternative to individual motor vehicle operation.

The continued provision of bus service and distribution of public information are in the interest of public health by facilitating the use of public transit rather than personal vehicles.

This program will be monitored through the Department of Transportation's routine monthly ridership analysis as well as the system-wide passenger count program. The receipt of reimbursement funds will be monitored by both the Department of Transportation and the Department of Finance.

RESOLUTION

Upon a communication from the Acting Commissioner of Transportation, be it hereby:

RESOLVED, that the County of Westchester is authorized to enter into an agreement with the New York State Department of Transportation for the receipt of \$1,375,000.00 (80% Federal STPX and 20% State SDF) for the operation of certain bus services, including the Westchester Shuttle Network and the management of bus stop information, as part of a regional transportation program for transit services provided during the period October 1, 2009 through September 30, 2010; and be it further

RESOLVED, that the County Executive or his duly authorized designee is authorized to execute all documents necessary to implement the purpose of this resolution.
