On December 15, 2010, thirteen (13) bids were received and opened for Contract No. 10-521 for Stormwater Wetland Construction and Streambank Stabilization, Scout Field, City of Mount Vernon, New York.

The bids were reviewed by the Department and it was determined that Landi Contracting, Inc. (WBE) submitted the low bid in the amount of \$240,783.50.

The low bidder has been investigated and it has been found that Landi Contracting, Inc. (WBE):

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to stabilize streambanks and create a wetland area adjacent to an existing stormwater outflow channel located in Scout Field Park.

This contract is in the public's best interest because it will provide an environmental benefit by reducing flooding and erosion, thus addressing the County Executive's priority area: Health and the Environment (HE).

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 10-521 be awarded to Landi Contracting, Inc. (WBE) in the amount of \$240,783.50.
