Westchester County Airport
Contractor: Gentile Construction Inc.
Amount of Amendment No. 1: \$100,000.00

On September 29, 2008, your Honorable Board awarded Contract No. WCA 08-005 to Gentile Construction Inc., 451 Old Nepperhan Road, Yonkers, New York 10703, for Snow Removal Service, Westchester County Airport, in the amount of \$600,000.00 for the three (3) year term commencing on November 1, 2008 and terminating on October 31, 2011.

Authority is now requested to amend this contract to add additional funds. Due to the unusually large amounts of snow and ice during the current winter season and the anticipated continuation of winter weather events requiring snow removal services, it is requested that an additional \$100,000.00 be added to this contract.

The goal and objective of this contract is to promptly remove snow and ice from traveled areas of the Airport. This contract will benefit the public by providing safe roadways and parking lots for travelers during the winter season through plowing and ice control. Airport Operations will oversee the contract and monitor performance by the contractor. Payment will only be made to the contractor upon satisfactory completion of a snow removal event and all roadways and parking areas are passable and in a safe condition for travelers.

It is my recommendation that Contract No. WCA 08-005 be amended to add an additional \$100,000.00, thus increasing the not to exceed three (3) year total contract amount from \$600,000.00 to \$700,000.00.

Payment for this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

This resolution has been reviewed by the Department of Law.

RESOLVED, that Contract No. WCA 08-005 between the County of Westchester and Gentile Construction Inc., 451 Old Nepperhan Road, Yonkers, New York 10703, for Snow Removal Service, Westchester County Airport, for the three (3) year term commencing on November 1, 2008 and terminating on October 31, 2011, be and is hereby amended to add an additional \$100,000.00, thereby increasing the total not to exceed contract amount from \$600,000.00 to \$700,000.00; and be it further

RESOLVED, that all other terms and conditions of Contract No. WCA 08-005 shall remain the same and in full force and effect; and be it further

RESOLVED, that the County Executive or his authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
